




Complete the TSA clearance process

Steps to Obtain a Hazardous Materials Endorsement



Contact your State Department of Motor Vehicle to ensure all information has been received

To ensure you have completed all the necessary steps:

 + Contact your State department of motor vehicles to see if your TSA clearance and scores for HME training are in the registry.

If you have an existing CDL B or A license, you will only need to take your written exam for the HazMat Endorsement. If you are obtaining a new CDL with a CDL-C rating, you will be required to first take the CDL General Knowledge Test prior to your HazMat Endorsement Test. Note: There is no Entry Level Driver Training required (in most states) for obtaining a CDL-C license. However, some states may require additional training and require a "walk-around or pre-trip inspection" - including a road test to ensure your ability to control your commercial motor vehicle.
